I have attended numerous schools during my tenure to enhance my expertise in the field of law enforcement, more particularly Criminal Investigations. I have successfully completed training in the fields of, Criminal Investigations, Criminal Evidence, Interview and Interrogations and Hate Crimes. While as a patrol officer I worked as a Patrol Evidence Technician. Than as a fulltime Forensic Officer, as well as serving on the public housing ACET Team. I am currently enrolled in the Criminal Investigator's Certificate Program at the North Carolina Justice Academy. I, the undersigned affiant Kevin J. Taylor, am a sworn law enforcement officer in the State of North Carolina, and employed as a detective with the Asheville Police Department. I have been a law enforcement officer for the past 23 years and have been assigned to the Criminal Investigations Division of the Asheville Police Department for the past 14 years. I have received an Associate of Arts degree in Law Enforcement from Kirkwood Community College and a Bachelor of Arts degree in Political Science from the University of North Carolina - Asheville. In addition to completing basic law enforcement training I have completed numerous other training courses, all of which totals well over 1000 classroom hours. Included in this training is courses in Police Law Institute and Homicide Investigation. I have also received my Advanced Certification from the North Carolina Criminal Justice Education and Training Standards Commission, and completed the Criminal Investigators Certification Program through the North Carolina Justice Academy.

On 07/31/06 the Asheville Police Department received a call from employees at Highwater Clays located at 600 Riverside Drive in Asheville in reference to skeletal remains found in the French Broad River behind the business. Further investigation led to the recovery of a human skull, two tibias, two knee caps, a partial left foot, and a lower jaw bone. The remains were clearly dismembered and cut into smaller parts, and most of the teeth were missing from the jaw.

On 08/07/06 the Asheville Police Department received a second call about human remains found in a culvert near the intersection of Roberts Street and West Haywood Street. Further investigation led to the recovery of both a right and left hand, and part of a left arm. Fingerprint comparison from the hands later identified the remains as those of Kelly Lane Smith, a local prostitute, who was last seen by friends on 07/29/06. Additional DNA analysis later by the North Carolina State Bureau of Investigation confirmed the skeletal remains found previously in the river were also those of Smith. The distance between the two locations is approximately 1 mile along Riverside Drive. The rest of Kelly Smith's bodily remains, including her entire torso, are still unaccounted for, as well as her clothing, jewelry, purse, and other personal possessions. To date no suspect has been charged in Smith's murder.

On 11/19/08 the Asheville Police Department received a call from she had been severly beaten. It also a local prostitute, had been solicited to perform a sexual act by a white male in a gold colored extended cab pickup with a camper top. This individual was later identified as Lewis Kyle Wilson who resides at 68 ½ Craven Street. Wilson drove to his residence where he then held her captive in an old camper on the property. Wilson beat her severly about the head and face, and stabbed her with a knife, while forcing her to perform sexual acts on him. Wilson later drove away from the residence and dropped her along the roadway where she then ran and called for help. Was transported to Mission Hospital where she was treated for her injuries. Wilson's pickup was located that same night at his residence and a criminal investigation was initiated.
Detectives also learned that two other local prostitutes had reported being beaten in this same area in the past. On 05/11/08 was picked up by a white male in a tan colored extended cab pickup and taken to 64 Craven Street where she was assaulted and raped both vaginally and anally. During the assault the suspect threatened to cut throat and throw her in river. In managed to escape and run to a nearby residence. On 08/06/08 was picked up by a white male in a gold colored extended cab pickup with a camper top and taken to 68 ½ Craven Street. She was beaten about the head and face, and knocked unconscious after refusing anal sex. When she regained consciousness was then transported away from the scene and dropped off alongside the roadway.
On 11/19/08 APD detectives executed a search warrant at Lewis Wilson's residence at 68 % Craven Street in reference to the assault of teeth, knives, saws, guns, bandcuffs, leg irons, pornography, computers, and cell phones. During the search detectives also discovered that most of the residence is uninhabitable. There is no running water or plumbing, and the interior is gutted of most walls. It appears as though Wilson lives in only one room of the house and that is the only area with heat. Also noted was that the interior of the house had two open areas in the floor where it appears there has been digging in the dirt foundation. An open crawl space is under the house and piles of fill dirt are located on the property, along with a burn pit.

From the second location where Kelly Smith's remains were found Lewis Wilson's residence is only ½ mile away. From the intersection of West Haywood Street and Roberts Street, Wilson's residence is straight across the French Broad River via the Craven Street Bridge, and then around a curve and up Craven Street. This entire area is a known location for prostitutes to carry on their trade.

On 11/22/08 APD Detective Paula Barnes interviewed

Lewis Wilson.

told Detective Barnes that during her relationship with Wilson she was physically and sexually assaulted on numerous occasions. She told Barnes that "this man is so dangersous," and that she is still fearful of him.

50-B domestic violence order on Wilson in the past.

also stated that Wilson frequently viewed pornography on his computer and had posted personal ads on the website Adultfinders. She stated that Wilson has accounts on both Myspace and Facebook and provided Detective Barnes with two email addresses for Wilson, journeyman77@yahoo.com and kyle@yogaplant.com

On 11/26/08 APD Detective Yvonne Cobourn charged Lewis Wilson with assault with a deadly weapon inflicting serious injury with intent to kill and first degree kidnapping in reference to the complaint.

On 12/02/08 was shown a photo line-up by APD Detectives Yvonne Cobourn and Mandy Buchanan. identified Lewis Wilson as the person who raped and assaulted her and that investigation continues. It is currently residing out of state and therefore has not been shown a fine-up.

Further investigation by APD detectives revealed that Lewis Wilson's mother, Mary Mahan, owns the residences at 64, 68, & 68 1/2 Craven Street, as well as the vacant lots at 60, 72, & 80 Craven. Street. Wilson is responsible for the upkeep of these properties, and according to tax records they were all purchased in 2004 and 2005. The residence at 68 Craven Street is currently being rented to a third party, while the residence at 64 Craven Street is unoccupied and uninhabitable. Lewis Wilson is using 64 Craven Street as storage and has run an extension cord to it from his residence at 68 ½ Craven Street.

Based upon the above statement of facts the affiant believes that probable cause exists to warrant a second search of Lewis Kyle Wilson's residence at 68 ½ Craven Street, as well as the vacant residence at 64 Craven Street, the vacant lots at 60, 72, and 80 Craven Street, and the curtiladge at 68 Craven Street. Specifically requested is that APD investigators be allowed to use cadeavor dogs to search the properties, and if needed, forensic methods to better examine them for any possible human remains or blood that may be present.
