1. What motivates you to apply for this position?

I am interested in serving on City Council to help ensure a better future for our community's children. I am willing to work hard to educate myself about the issues facing our city and region. It is possible that there are other potential Council members with more political savvy, more connections, and more relevant experience, but I am sure there isn't anyone who will work harder to represent this constituency. As a parent of two, a former teacher, and an educational non-profit professional, I am very aware of the needs of children and families. I respectfully ask City Council members to allow me the opportunity to represent Asheville's children and families for one year on City Council.

2. Where do you fall on the conservative-liberal spectrum in terms of fiscal and social policy? I believe it is imperative that we give a hand, but not a hand-out, to those who are unable to help themselves. I support initiatives that assist those families and individuals living in poverty gain access to education and housing. However, I am aware that we must be fiscally responsible and set aside a prudent reserve for the future. I would align myself most closely with the priorities of progressives such as Barack Obama.

3. In your eyes, what should be the top 2 or 3 priorities our City Council should be focused on in the upcoming year and why?

I am encouraged by the four priorities outlined in the City Council's Strategic Operating Plan. I am most supportive of the goals outlined in the "Affordable" and "Safe" categories, especially the ten-year plan to end homelessness and the educational initiatives like CAYLA and the ABTech Yes Camp. I support the "Green" and "Sustainability" initiatives, though many of them may have to be delayed due to budgetary constraints.

If I am chosen to serve on City Council for the next year, I will endeavor to move the city forward on these important issues. I am not interested in bickering or wasting time. There is good and important work to be done for our community and its citizens, and I pledge to put my efforts into supporting that work.

4. What do you consider the most crucial problem, need, or cause for the citizens of Asheville? How would you approach its resolution or champion the cause?

Economic sustainability is key for our future. We must support the economic engine of our community, and the sustainability of business, if we expect to continue on our current path of success. I am very concerned about job creation, workforce housing, homelessness, and the cost of living in our city. I believe the City Council's stated priorities in their Strategic Operating Plan address many of these issues, and I pledge to work with other council members towards solutions for these problems.

5. 2008-09 and 2009-10 fiscal years will be financially tough for the City. What will be your top funding priorities and what would you like to see reduced to balance the budget?

Obviously, the services provided to citizens by the city must be re-evaluated. This may mean a hiring freeze or even layoffs in city staff, and it will clearly mean tightening our belt in terms of vehicle and public land maintenance, park acquisition, and road upkeep. However, I would not support cutting housing and/or social services budgets for those most in danger of becoming homeless. Clearly, I would support any initiatives the city currently has in place to end homelessness and to provide workforce housing.

I know that the next year will be a tough one financially, but I would like to work to help City Council to find innovative ways to harness the faith and the non-profit community to continue serving our families and children who live in poverty.
