- 3. In your eyes, what should be the top 2 or 3 priorities our City Council should be focused on in the upcoming year and why?
- a. Continue to improve the infrastructure and utilities. Because many of our internal systems have become

old and outdated, we need to ensure that these systems are improved and modernized so that future growth will

not be compromised.

b. The Civic Center issue needs to be addressed and resolved once and for all. We need to look at remodeling,

improving, or relocating this resource that has beome tarnished in the past few years. It can be a

tremendous resource if brought up to the proper standards and to the level it was once designed to serve in our

community.

c. The City Council and our city planners need to address the UDO policy to make it more "citizen-friendly."

Many residents, future home owners, and builders are unknowledgeable about the policies and procedures that this document addresses.

We need to make it more viable and understood by those who will be affected by it.

4. What do you consider the most crucial problem, need, or cause for the citizens of Asheville?
How would you approach its resolution or champion the cause?

I feel the biggest issue to face us is taxation. In these difficult and challenging economic times, I feel that

we should not raise taxes and cause further burdensome problems for our citizens and businesses. We need to attract

more businesses so that we can offer employment opportunites and raise our tax base. We should look at other cities

that have been successful in doing this, both instate and out of state. Since our number one industry is tourism,

I feel it is crucial that we find more innovative ways to bring tourists into our area as has been done by such towns

as Pigeon Forge, Tennessee and other areas surrounding us. We have a wonderful Chamber of Commerce building and we

need to partner with the Chamber to optimize attracting more conventions and tourists to our area. We must also

work with the Tourism Board to ascertain their needs and the support they require to support the tourism industy

here in Asheville.

5. 2008-09 and 2009-10 fiscal years will be financially tough for the City. What will be your top funding priorities and what would you like to see reduced to balance the budget?

Since I am not privy to the city's current funding priorities and capital needs/expenditures, I am not

able to make any comments on supporting funding priorities or reducing or eliminating programs or

entitlements concerning our budget. However, your statement concerning our tough financial times for the next

fiscal year and beyond are correct. I feel that the City Council should request from the city manager that all

departments bring to the council by Febr 1, 2009, a 10% reduction of all department budgets. The Council should $\overline{}$

prioritize the cuts versus the needs so that there is a rationale for reducing some budgets more than others.

I also feel that each department head should look at their staffing requirements to see if there are individuals

whose hours could be reduced to a 30 hour work week so they could continue their employment with benefits.

I would rather reduce hours than have a layoff or termination. I think with the overall departmental reductions in

hours, we can bring this budget into the balanced column and continue to provide adequate services to our citizens.

It will take a total team effort and the cooperation of all management and council members to ensure the city's $\frac{1}{2}$

financial stability for the near term.
